

JUDGING SCHEDULE for Palouse Hills Dog Fanciers agility trials, June 17, 18, 19, 2016

Welcome to the PHDF AKC agility trials! We have ordered great weather, but please bring appropriate clothing for all conditions just in case! This is a preliminary judging schedule which is contingent upon the move-up entries that may not have been received yet. Numbers of dogs in each height within each class are listed below. We appreciate everyone's cooperation in being prompt at the start line, and volunteering to help time, scribe, gate, set bars, or run leashes when you can! Many judges have commented that Northwest exhibitors are OUTSTANDING in their "pitch in and help" attitude!

If you have requested a moveup, PLEASE check your final confirmation to make sure your dog was moved up as requested! And even if you don't have a moveup, please read your confirmation carefully anyway! Your Trial Secretary thanks you!

On Friday, the grounds will open for exhibitor setups starting at **12:00 noon**. The club will be setting up the rings before noon, so please do not attempt to set up before that time. **IF YOU CAN HELP WITH RING AND EQUIPMENT SETUP on Friday morning**, we would really appreciate it, as the club has a small membership. PLEASE NOTE: To protect the grass, MATTING is required under all crates and ex-pens.

Classes will alternate between the two rings (exception – all FAST classes are in Ring 1). Course building and walkthrough will take place in one ring while the other ring is running. Excellent/Master classes will have split walkthroughs each day; 4, 8, 12, and 16 EXCELLENT/EXCELLENT P walk and run, and 16 MASTER/MASTER P, 20, 24 and 26 walk and run. This provides the most even distribution of dogs and handlers for the walk-throughs.

Friday: Judging starts at 2:00 PM. FAST Ex/Master, Open, Novice (all Ring 1), JWW Ex/Master (Ring 2), STD Ex/Master (Ring 1)

Saturday: Judging starts at 7:30 AM. STD Ex/Master (Ring 1), JWW Novice (Ring 2), STD Open (Ring 1), JWW Ex/Master (Ring 2), STD Novice (Ring 1), JWW Open (Ring 2), FAST ExMaster, Open, Novice (all Ring 1)

Sunday: Judging starts at 8:00 AM. STD Ex/Master (Ring 1), JWW Novice (Ring 2), STD Open (Ring 1), JWW Ex/Master (Ring 2), STD Novice (Ring 1), JWW Open (Ring 2), T2B (Ring 1)

MEASURING: Ann McQuillen is a VMO, so any dog that does not have one of the following: 1) permanent height card, 2) two official permanent measurements that place the dog in the same height division, or 3) a valid (unexpired) temporary measurement (dog under 2 years old), must be measured, regardless of the jump height entered. You may have unentered dogs measured as long as they are at least 15 months old, but please wait until later in the day/weekend to do that, so that competing dogs can get their measurements done before they run.

DIRECTIONS TO TRIAL SITE

From the south: From HWY 95 N, turn RIGHT on HWY 8 East (second light in Moscow). Go 1 mile to light at Eastside Marketplace Mall and turn LEFT on Blaine St. Go one block, turn RIGHT on White Ave. Fairgrounds entrance is first road on LEFT.

From the north: take HWY 95 S into Moscow (becomes one-way Jackson St.). At south end of town, street bends left (east). In left lane, go through light onto HWY 8 East. Go 1 mile to light at Eastside Marketplace Mall and turn LEFT on Blaine St. Go one block, turn RIGHT on White Ave. Fairgrounds entrance is first road on LEFT.

From the west: On Hwy 195 S, take first Pullman exit. At light, turn RIGHT onto Grand Ave. At second light, turn LEFT onto one-way Paradise (becomes Main). Continue east on Main/WA 270 for about 7 miles. At ID border, WA 270 becomes ID HWY 8 East. Go 1 mile to light at Eastside Marketplace Mall and turn LEFT on Blaine St. Go one block, turn RIGHT on White Ave. Fairgrounds entrance is first road on LEFT.
